

The CM/ECF Implementation Committee reminds attorneys that they must become registered users of CM/ECF prior to January 1, 2006. Attorneys who are NOT registered users of CM/ECF are listed in the following document. Pursuant to Section 2 of the Court's CM/ECF Policies and Procedures, adopted by the Board of Judges on April 20, 2005, attorneys who are not registered users of CM/ECF by the January 1, 2006 deadline will receive a Show Cause Order. All Show Cause hearings will be held before the Judge who chairs the Court's Information Technology Committee. The current chair is Judge Arthur J. Schwab. The list was compiled by searching all PENDING cases in which the attorneys are listed as active counsel and are not currently registered users. If your name is listed, but you are no longer representing a party on a pending case, you will need to withdraw your appearance. The registration requirement applies to all counsel listed on docket sheets, whether they are admitted pro hac vice or are listed as being "of counsel." To find the cases in which you are listed as counsel, use your PACER account at the following website: <https://ecf.pawd.uscourts.gov> On the blue menu bar at the top of the screen, select "Query." On the query screen, in the last name field, type in the last name of the attorney. In the first name field, type in the first few letters of the attorney's first name. In the "Type" box, select "Attorney."
