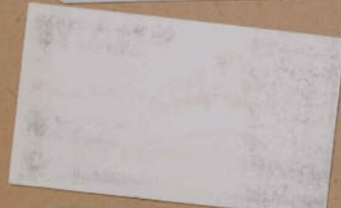

 Do not talk further unless your lawyer requests"

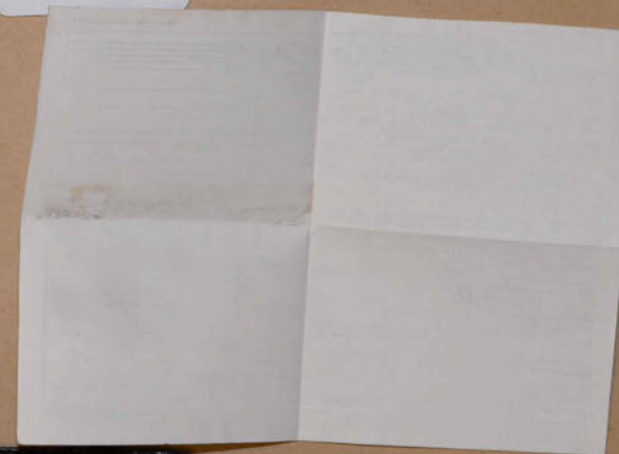
