**ORDER GRANTING JOINT MOTION TO MODIFY PRETRIAL ORDER NO. 25
APPROVING CENSUS REGISTRY PROGRAM AS PRETRIAL ORDER NO. 25(a) AND
TO MODIFY PRETRIAL ORDER NO. 26 REGARDING FACT SHEET
IMPLEMENTATION AS PRETRIAL ORDER NO. 26(a)**

The Court, upon consideration of the Joint Motion by Plaintiffs and Defendants to Modify Pretrial Order No. 25 Approving Census Registry Program as Pretrial Order No. 25(a) and to Modify Pretrial Order No. 26 Regarding Fact Sheet Implementation as Pretrial Order No. 26(a), it is hereby ORDERED that the Motion is GRANTED.

The Court approves the parties' proposed modified Census Registry Form. A Potential Claimant who has already submitted a substantially complete Census Registry Form pursuant to the Census Registry Program Agreement need not serve a modified Census Registry Form. Further, the Court approves, and will enter separately on the docket, Pretrial Order No. 25(a), which includes the modified Census Registry Form.

The Court approves the parties' proposed modified Plaintiff Fact Sheet form. A Plaintiff who has already submitted a substantially complete Plaintiff Fact Sheet pursuant to Pretrial Order No. 26 need not serve a modified Plaintiff Fact Sheet. The Court also approves the parties' proposed modified Defendant Fact Sheet form. The Court further approves, and will enter

separately on the docket, Pretrial Order No. 26(a), which includes the modified Plaintiff and Defendant Fact Sheets as Exhibits 1 and 2, respectively.
