**PRETRIAL ORDER #23**  
**AGENDA FOR SCIENCE DAY**

Having reviewed the Parties' Joint Motion Setting Forth Proposed Agenda for Science Day and Response to Court's Science Day Order (Pretrial Order #21), the Court grants the Motion and hereby Orders as follows:

Science Day will proceed on the following schedule:

- Science Day to begin at 10:00 a.m. ET.
- The Philips defendants will present first, for approximately one hour and thirty minutes.
- SoClean, Inc. will present second, for approximately one hour and thirty minutes.
- The Philips defendants and SoClean will complete their presentations by 1:00 p.m. and the Court expects to then take a one-hour break for lunch.

- The consumer plaintiffs in both MDLs will present third, for approximately two hours and fifteen minutes.

Philips' Plaintiffs' Co-Lead Counsel Kelly K. Iverson is permitted to attend Science Day remotely, subject to the following: (1) Ms. Iverson will only attend and watch, but not participate in any presentations; (2) her remote line shall remain muted except to the extent she is asked to enter her appearance for the Court; (3) no video, screen captures, photos, pictures, recording, or other methods of recording will be taken; and (4) remote attendance will only occur from a location where it is ensured that other individuals are unable to view or hear the presentations.

Plaintiff's counsel in litigation filed in Massachusetts Superior Court ([Bernheim Kelley Battista & Bliss, LLC](#)) may attend Science Day solely to observe (not to participate), provided that counsel files with the Court prior to Science Day an acknowledgement that they agree to comply with Pretrial Order #21, including regarding confidentiality, and are subject to the authority of this Court in the event of noncompliance.

Except as otherwise stated herein, the Court's Pretrial Order #21 related to Science Day shall govern the conduct and attendance at Science Day.
