PRETRIAL ORDER No. 22
STIPULATION AND ORDER re: KPNV's Personal Jurisdiction Defense

This stipulation and order is entered into by and between Plaintiff SoClean, Inc. and Defendant Koninklijke Philips N.V. (“KPNV”).

1. KPNV previously moved to dismiss Plaintiff’s Amended Complaint for lack of personal jurisdiction under Fed. R. Civ. P. 12(b)(2). *See* Dkt. Nos. 64, 64-1, 64-2.
2. To provide for the efficient adjudication of KPNV’s personal jurisdiction defense, the parties agree to defer KPNV’s jurisdictional challenge and related briefing until later in pre-trial proceedings before this Court to allow for relevant jurisdictional discovery. In doing so, the parties agree that (1) in participating in further proceedings before its jurisdictional challenge is briefed and decided, KPNV is not waiving, and is expressly preserving, its jurisdictional defense in all respects, and (2) KPNV will participate in discovery (including non-jurisdictional discovery) when the fact discovery period commences on August 12, 2022. *See* Dkt. No. 117.
3. Jurisdictional discovery shall proceed for 90 days, beginning with the start of fact discovery and ending on November 10, 2022. In the event KPNV intends to seek dismissal for lack of personal jurisdiction following the conclusion of that 90-day period, the parties will submit a briefing schedule for the Court’s approval.
