**PRETRIAL ORDER #7**  
**ORDER REGARDING ADMINISTRATIVE DOCKET CONTROL**

In ECF No. 3, Pretrial Order #1, this Court set forth the rules on filing documents in this MDL, “**In Re: SoClean, Inc., Marketing, Sales Practices & Products Liability Litigation**” Western District of Pennsylvania case number **22-mc-00152** and the Multidistrict Litigation case number **MDL 3021**. For clarity, the entirety of this MDL (and all cases transferred to this Court by the JMPL for purposes of this MDL) is known as **MDL 3021**.

Not all filings relate to all cases and the selection of the voluminous party names on ECF/Pacer can make the process of filing a document complicated and time-consuming. To address these issues, and in response to the discussion between the Court and counsel at the May 19, 2022 Case Management Conference, the Court enters the following **ORDER**:

1. The Court adopts the following three categories that may be used in the caption of any filing:

- **All Cases.** This designation applies when the filing applies to all cases transferred to this Court as part of MDL 3021.
- **All Consumer Cases.** This designation applies when the filing applies to all cases in this MDL that are having their claims prosecuted by leadership appointed in Pretrial Order #2 (Doc. 25) including the following case numbers and any other future cases transferred to this Court as part of MDL 3021 meeting this criteria:

- ***SoClean, Inc. v. Koninklijke Philips N.V. et al*, 2:22-cv-00542-JFC**: This designation applies when the filing applies to the lawsuit captioned *SoClean, Inc. v. Koninklijke Philips N.V. et al.*, 2:22-cv-00542-JFC.

2. The Clerk is directed to add a Party option in ECF for “Consumer Plaintiffs,” which can be used when co-lead counsel appointed in Pretrial Order #2 (or those they have approved to file) are filing in the “All Cases” or “All Consumer Cases” categories on behalf of all plaintiffs for whom they are prosecuting claims.
