<p><FirstName><LastName>, you have been randomly selected as a prospective juror by the United States District Court for the Western District of Pennsylvania. Serving on a jury is both an honor and responsibility of American citizenship and federal law <u>requires</u> you to complete a Juror Qualification Questionnaire to determine if you qualify to serve as a juror in federal court. 28 U.S.C. §1864(a). <u>This is not a summons for jury duty, and you are not being called to report at this time.</u> Instead, you are only completing a questionnaire to determine your eligibility to serve as a juror in federal court.</p>	
<p>Please complete this questionnaire within ten (10) days of receipt of this postcard by going to the Court's website, www.pawd.uscourts.gov, clicking on the "For Jurors" tab, and selecting the "eJuror" link from the drop-down menu. You can also scan the QR code on the front of this postcard and it will take you to the site to complete the questionnaire. You will need your nine (9) digit participant number, located above your name on the front of this postcard. If you do not respond, a paper questionnaire will be mailed to you with directions to complete and return for processing.</p>	
<p>If you qualify, you may be summoned to appear for jury service at a later date. If you are summoned, you will receive additional instructions regarding your service, including the date and location where you should appear and information about compensation you may receive.</p>
