About the Training:

Lynn MacBeth's mediation training provides a foundation in theory and practice of civil and family mediation. It begins with history of mediation in America followed by a study of mediation styles and their applications. Family systems and communication theory are examined and applied to conflict scenarios. Mediation techniques for responding to and managing conflict and high emotion are offered as well as more than two dozen advanced techniques. The course includes 2 hours of ethics, 2 hours of domestic violence training, and 16 hours of mediation simulation practice, as required in many programs. Students will view a live mediation demonstration and several video demonstrations, in addition to participating in numerous mediation role-play scenarios. The training provides a foundation for all types of mediation.

Lynn MacBeth is a child custody mediator in the Generations program for the Allegheny County Court of Common Pleas and mediator of employment disputes for the U.S. Postal Service, the U.S. District Court of Western Pa. U.S. EEOC and U.S. Bankruptcy Court. In addition to her private mediation practice, she is an Adjunct Faculty member of Duquesne University School of Law where she teaches *The Art of Mediation*.
